

Q1 What would be your estimated timeframe to achieve CCAK?





Q2 If you indicated interest in achieving CCAK within its first 2 years of existence, please rank the following reasons in order of priority (highest to lowest)





Discounted pricing and bridge courses for CISAs.

Design train the trainer material and courseware that's achievable, and differential pricing strategy for emerging markets.

Basic principles of auditing should be included in the curriculum, such that an individual who does not have initial audit experience but interested in auditing in the cloud can pursue the certification without achieving either CISA or CIA before achieving the CCAK credentials.

Establish competitive certification price.

Labs and a real life issues.

Partnerships with other certification bodies for cross CPE recognition and promotion.

Need to figure out how to update it regularly to keep pace with industry changes.

Needs to be offered virtually.

I personally believe that CCSK certificates should receive a discount or bonus to get CCAK certified with a discount for being a CSA member.

Work with Institute of Internal Auditors (IIA)

Need to figure out how to align it with major cloud provider's training to help understand the technical differences of each.
